Before submitting an application, please complete the "initial project concept" form at <http://www.nkdf.org/how-to-apply/application-forms> to determine if the project is eligible to apply for funding. After receiving your initial project concept, we will respond within three business days. If we indicate the project is eligible to apply for NKDF funding, please complete the "Application Form" and submit it along with all attachments to manager@nkdf.org. We recommend downloading and saving the document, entering a small amount of text and then saving. Close the document and reopen in order to ensure the document is saved with your text and working properly.
